All parties who have filed a brief in this matter are permitted to argue. The hearing is thirty (30) minutes to be shared by all parties arguing (or 15 minutes if only one side of the appeal is arguing). All parties entitled to argue are to be present no later than thirty (30) minutes before the assigned hearing time.

A request for waiver of the hearing may only be made by written agreement of <u>all</u> parties entitled to argue. An individual party may only request waiver of their own appearance at oral argument. Parties have until seven (7) days from the date of this Order to file a written request to waive their appearance at oral argument, or to file a joint request to waive the hearing itself. Parties must immediately notify this Court by phone or fax of the intent to waive. Failure to appear without proper waiver may result in sanctions.
